
As part of this commitment, Trafimar has an environmental risk assessment. It promotes the identification of alternatives to protect, preserve the environment and modify our behavior for a continuous improvement in the quality of life.

Trafimar works with a health, security and environment program created to comply with government regulations that apply to our line of business and create a safe workplace for our employees and partners. We also make sure that our HSE program works hand in hand with our Quality Management System.


Trafimar has implemented the following strategies as a priority to reduce our environmental impact. It is also included in our social responsibility policy.



Turn off all the assigned electrical equipment when we are not using them and at the end of our workday. Making sure they are all off and all lights in our work area are turned off.



Trafimar has installed solar panels in its facilities. These panels are generating 100% of the electricity consumed in our warehouse and offices.




This has resulted in a reduction of 78,367 KGS of CO2 emissions in our facilities.






Our air conditioning system is optimized with preventive and corrective maintenance to prevent leaks or heat losses at the time of year when it is necessary to use.





We use bond paper responsibly. Trafimar has increased the use of electronic files that help prevent the storage and use of paper, with the help of scanning and digital documents.




With this action, Trafimar has contributed to saving approximately 80,190 liters of water.

In Trafimar we encourage our partners and employees to avoid the use of single-use plastics and Styrofoam inside our facilities.

In an effort to eradicate the single-use plastics inside our facilities, Trafimar has provided all the employees with water containers for their drinking water, this initiative was completed in December 2023.







In Trafimar we encourage our employees to create microclimates in their workplaces, we are currently working on reforesting the surrounding areas of our facilities.





We are currently in an internal campaign encouraging our employees and partners to donate a tree or an endemic plant to help reforest the surrounding areas of our facilities. We have reforested 50% of our surrounding area.







The hazardous waste that is generated in our facilities has been located in a secure place to prevent leaks and they are safely eliminated by a certified **SEMARNAT** supplier.



With this process, Trafimar contributes to saving 200,000 liters of water every 6 months.





Trafimar has a permanent campaign to collect used batteries and sustainably dispose of them. We encourage our employees and partners to contribute with their used batteries and help with this project.

In 2023, we collected 35 kg of batteries which were disposed of sustainably. This way Trafimar has contributed to stopping water from being contaminated with mercury, cadmium, and lead. A single battery can contaminate 600,000 liters of water.

In recognition of the sustainable disposition of 35 kg of batteries collected by our partners and employees, Trafimar received a certificate from **Recilcadora GreenityS.A de C.V** and obtained ten trees that were planted in the surrounding area of our facilities.


